# BECKRYSIL ® PAINT SYSTEM Limited Paint Warranty

## COVERAGE

Insert Company Name, extends this warranty to panels, effective from the date of shipment aand sold as a warranted or Number One panels as indicated on the customer's original invoice. It applies only to goods used on wood frame buildings and on architectural, commercial, pre-engineered or residential metal buildings, which are installed in the United States, Canada, and Mexico. This warranty shall extend to the purchaser of the material and is non-assignable and/or non-transferable. Should the purchaser become insolvent, bankrupt, make an assignment for the benefits of its creditors, or for any reason discontinue its normal or regular business practices, this warranty shall for with become null and void and of no legal effect. The purchaser must present the original sales receipt for warranty consideration.

## **TERMS**

Although it is recognized by Insert Name that most coatings, including BeckrySil<sup>®</sup>, will fade and change in appearance to some degree over a period of time in outdoor installations, and that such changes may not be uniform between surfaces not equally exposed, Insert Name warrants that the goods covered by this warranty will resist natural weathering to the extent that they will conform to the performance standards below during a period of 40 years for film integrity and a period of 30 years after shipment for both chalking and color change, provided that all conditions of this warranty are first met. Provisions (1) through (3) below apply to buildings installed north of the 15° parallel of latitude in the northern hemisphere. Only provision (1) applies to buildings south of this latitude.

- 1. For forty (40) years, BeckrySil<sup>®</sup> will not peel, flake, or otherwise lose adhesion to an extent that is apparent on ordinary outdoor visual observation. Note: Slight cracking may occur on roll-formed edges or break bends at the time of forming, and is considered as standard, such cracking shall not constitute a basis for complaint under this limited warranty; and
- 2. For thirty-five (35) years , BeckrySilh® will not chalk in excess of a numerical rating of seven (7-vertical installations),(5-non-vertical installations) when measured in accordance with the standard procedures specified in ASTM D-659 and NCCA 111-8; and
- 3. For thirty-five (35) years, BeckrySil® will not, fade or change in color in excess of five (5) NBS units (vertical installations), or seven (7) NBS units (non-vertical installations) following installation. Color
- Measurements are to be made per ASTM D-2244 and only on clean surfaces after removing surface deposits and chalk per ASTM 3964.

### **EXCEPTIONS**

This is an anti-weathering limited warranty and does not apply to other causes of degradation, including:

- a. BeckrySil® which has suffered scratching or abrasion or impact by a hard object; has been abused, altered, modified, used in a manner not originally intended or stored contrary to instructions of Insert name here, or in accordance with good industry practice; is damaged due to moisture entrapment in bundles during transit or storage; is stored or installed in a way which allows standing water on the coating or in any chemically aggressive environment containing fumes, ash, cement dust, carbon black, salts or other chemicals whether naturally occurring or caused by man; is stored or installed in a way which allows contact with animals and/or animal waste or its decomposition products; is stored or installed in an area, or in such a way, that damage can occur due to poor air circulation; caused by acts of God, radiation, falling objects, explosion, fire, riots, civil commotions, acts of war, or other external forces;
- b. BeckrySil<sup>®</sup> which suffers from improper forming, fabrication, or embossing; cut edge exposure; corrosion of the substrate; or the development of any other condition between the coating and the substrate which causes the coating to degrade or delaminate, including any failure or deficiency in the cleaning process or pretreatment;
- c. BeckrySil® which is installed within 1000 meters of salt water or other marine environment;
- d. This warranty will not extend to or cover damages to the material due to improper shipping, handling, installation, storing, erecting of the panels on the job site and/or any act of negligence of the customer or any third party after the panels leave the possession of insert name here. Claims arising from the following conditions will also not be warranted; a) Steel shavings from sawing sparks that come into contact with the paint surface. B) Damage to the paint surface due to the use of an abrasive saw blade. C) Panels used on or near animal confinement. D) Damage due to the use of wet, green, or treated lumber. E) Use of fasteners not recommended by Insert name.

## REMEDY

If any of the products fails to perform as warranted, the company will repaint or replace the defective panels at its sole discretion, and insert name shall bear no liability, except to the options listed above. If insert name chooses to replace the defective material, the liability is expressly limited to the purchase price of the defective material, and labor costs will not be given due consideration. Insert name will not be held responsible for any losses, damages, or expenses caused by or resulting from the use of defective material. Insert name reserves the right to terminate or modify this warranty except with respect to orders already accepted.
